I am writing to you in strong support of the Community Project Funding application submitted by Moon Transportation Authority (MTA) for their project Market Place District Transportation Improvements. MTA has been successfully implementing major transportation infrastructure projects in Moon Township for 35 years.

This Project will reconstruct a 1.25-mile segment of Montour Run Road and its intersection with Market Place Boulevard to enable private development on 300-acres along Market Place Boulevard.
