Electronics / Appliances

- **No Fee**
- Computers
- Laptops
- Computer monitors
- Printers, copiers, fax machines, scanners
- Computer peripherals, keyboards, speakers
- Radio, telephones
- Hard drives destroyed no additional charge
- Stoves
- Air conditioners
- Dehumidifiers
- Microwaves
- Refrigerators
- **TV's –limited to one per vehicle**

Home Healthcare items

- **No Fee**
- Crutches, canes
- Folding walkers
- Shower transfer benches
- Wheelchairs, MANUAL
- Nebulizers
- Portable suction pumps
- Medical Supplies, unopened, with 1 yr. before expiration.
- **No Medications**

Tires

- Passenger and light truck tires - **No fee**
- Large truck tires **\$5** per tire
- Tires w/ rims; there will be an additional **\$5** charge per tire
- Tires larger than 24" cannot be accepted. Please contact Liberty Tire directly 330-868-0097

NOTE: This event is a **Recycling Event**, **not** a Household Hazardous Waste Collection event. We are collecting materials that can be reused in some form.
Household Hazardous Wastes (HHW) are those wastes produced in our households that are hazardous in nature, but are not regulated as hazardous waste, under federal and state laws. Each person in Pennsylvania produces an average of four pounds of HHW each year, or about 25,000 tons/yr. state wide. Included are such items as old paints and paint related products, pesticides, pool chemicals, drain cleaners, and degreasers and other car care products.

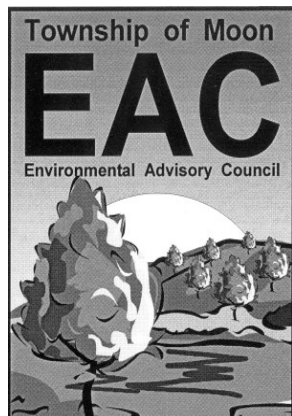

Important Notice- New Pennsylvania Law: Covered Device Recycling Act (CDRA)

After **Jan. 24, 2013**, no person may dispose of a covered device or any of its components with their municipal solid waste. These devices and their components (televisions, computers, computer monitors, and computer peripherals) must be properly recycled and may not be taken to, nor accepted by, landfills or resource recovery facilities for disposal or processing. To accommodate this new state regulation Moon Township has increased the number of electronic collection events. In addition to the June 6th Recycling Day event **Moon Township will hold electronics collections on Saturdays, March 7, August 1, and October 3, 2015**. The electronics collection will be held in front of the Municipal Building at 1000 Beaver Grade Road from 10 a.m. to 2 p.m. The additional events are for electronics only.
