Add Alternate No. 1 – Construction of Plumbing for Finish Rooms

Per the Instructions to Bidders, the bid bond companies were checked and all are listed on the U.S. Treasury Circular 570.

In accordance with Section B.3 of the Instructions to Bidders, using the bid quantities and contractor bid unit prices, the bids were checked for mathematical errors in extension and addition. No errors were discovered in the bids received. The enclosed bid tabulation presents a listing of the item descriptions and Unit Price Bid for each item for the bid received. As presented above and in the bid tabulations, the apparent low bidder for each contract is as follows: Swede Construction Corporation (General), Acme Bros. Plumbing Contractors Co. (Plumbing), A-1 Electrical, Inc. (Electrical) and Reno Bros., Inc. (HVAC).

A-1 Electric, Inc. submitted a letter to LSSE on March 19, 2020 to withdraw their bid as a result of a mathematical error when preparing their bid proposal. A-1 Electric, Inc. discovered that they excluded the costs of materials in the amount of \$31,287.00 from the proposal submitted.

The table below provides a summary of the combined costs of all Contracts (19-PW1, 19-PW2, 19-PW3 and 19-PW4) for both Base Bid only and for Base Bid and all Alternates. The Base Bid scope of work includes the construction of the maintenance garage including floor drains, heating and lighting for garage bays, an interior wall that separates the garages from the office areas and rough-in plumbing for future office spaces. The office areas would remain unfinished with a stone floor. The add alternates include the installation of a concrete floor for offices, construction of mezzanine and finishing office areas which includes a breakroom, conference room, office, utility room, restrooms and storage room.

Based on the bids submitted, we suggest award of Contract No. 19-PW1 – General Construction to Swede Construction Corporation in the amount of \$385,000.00; award of Contract No. 19-PW2 – Plumbing to Acme Bros. Plumbing Contractors Co. in the amount of \$56,200.00; award of Contract No. 19-PW3 – Electrical to Westmoreland Electrical Services, LLC in the amount of \$92,000.00; and award of Contract No. 19-PW4 – HVAC to Reno Bros., Inc. in the amount of \$30,995.00. The award of each Contract is subject to the respective contractor obtaining the required insurance certificates, performance bond, and payment bond, and review and approval of same by the Township Solicitor prior to execution of the Agreement by the Township.

Award of the Add Alternates are contingent on Township's review of budget.
